**8. Brief description:**

In order to carry out the analysis, the experts group will draft an analysis of Romania's commitments as a member of the European Higher Education Area and an analysis of

the Education Law deriving from these commitments.

The results of the activity will include policy recommendations for fulfilling the EHEA commitments and also a proposal for a new funding model that will underpin these commitments.
